## Discussing Birth Options Following Cesarean Births

RCP is seeking your feedback to help us revise our current resources and to enhance the provincial tools available to support care providers when having discussions with patients about birth options for a person who has had a previous cesarean birth.

## Current RCP Resources Available:

- Maternal-Newborn Clinical Guideline: "<u>Discussing Birth Options Following Cesarean Section in</u> <u>nova Scotia: Vaginal Birth after Cesarean (VBAC) or Elective Repeat Cesarean Section</u>" (2015)
- Health Care Provider Resource: "<u>Planning for Birth after a Cesarean Section: VBAC (Vaginal Birth</u> <u>after Cesarean) or Repeat Cesarean</u>" (2015)

- Discuss the risks and benefits of a trial of labour and elective repeat cesarean.
- Discuss the possible impacts of a trial of labour and elective repeat cesarean on future pregnancies.
- Present Nova Scotia specific data about VBAC success rates.
- Present local facility specific data about VBAC success rates.
- Discussion about the individuals likelihood of a successful VBAC, based on individual clinical factors (age, BMI, history of previous vaginal birth, dystocia as indication for previous CS).
- Use of VBAC prediction models/calculators to aid discussion about the individuals likelihood of a successful VBAC.
- Discussion about the factors that may influence a need or desire to change the planned birth option.
- Discussion about the available options for induction of labour, and associated risks, in the case an indication for induction arises for those individuals who have chosen a trial of labour.
- Discussion about what to expect the intrapartum and postpartum care may look like for a trial of labour, successful vaginal birth, and repeat cesarean (ex. type of fetal monitoring, supportive care in labour & factors that may facilitate a successful VBAC, expected length of stay in hospital, expected postpartum recovery, expectations for care of other children during the postpartum period).
